

Acknowledgement of Risk, Release, Indemnity Agreement

I, _____, hereby acknowledge that I am voluntarily entering onto the premises of the shooting range to participate in or observe shooting-related activities during the “Men of Honor” or “Band of Brothers” Boot Camp event taking place from _____, 2025 to _____, 2025, hereinafter referred to as “The Event.” I understand and agree that this waiver, release, and indemnity applies solely to activities conducted in connection with The Event on the specified date(s) and shall expire upon the conclusion of The Event. I further acknowledge and understand that “activities” includes, but is not limited to, the handling, discharge, and observation of firearms; safety demonstrations; and any other event-related activities occurring on the premises during The Event.

_____ Initial

I ACKNOWLEDGE AND UNDERSTAND THAT SHOOTING ACTIVITIES ARE INHERENTLY HAZARDOUS and involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or others. These risks include but are not limited to: being shot by or shooting myself or others; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; and being struck by flying or falling objects. I understand that such risks cannot be eliminated without compromising the essential qualities of shooting activities.

_____ Initial

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT the nature and condition of the RANGE facilities, premises and environment is such that both known and unanticipated hazards exist which create and contribute to both known and unanticipated risks inherent in entering on to the RANGE, in using RANGE facilities and in engaging in or observing any activities of any kind whatsoever while at the RANGE. I understand that such hazards and risks cannot be eliminated without compromising the essential qualities of the RANGE facilities, equipment, premises and environment.

_____ Initial

Participants and observers agree to abide by all rules and regulations in effect at the shooting range where The Event is held, including but not limited to any safety protocols, conduct expectations, or operational restrictions established by the range operator. In the event of any conflict between the Range Rules set forth herein and those established by the range, the more restrictive rule shall govern and must be followed. If the shooting range has not established specific rules or policies covering a particular issue, then the rules set forth in this agreement shall apply and must be adhered to in full.

_____ Initial

Range Rules

1. Follow all range commands.
2. Treat every firearm as if it were loaded.
3. Keep every firearm pointed in a safe direction (downrange) at all times.
4. Keep your finger off the trigger until you are ready to fire.
5. Know your target and what is beyond it.
6. Wear eye and ear protection while on the range.
7. Shoot only at authorized targets.
8. Never go forward of the firing line.
9. Be alert for unexpected actions by other people and report unsafe behavior.
10. Be sure your gun is safe to operate.
11. Know how to use your gun safely. If you don't know, please ask.
12. Use only the correct ammunition for your gun.
13. If your firearm malfunctions, leave it at your stall pointed downrange and ask a Range employee or line instructor for assistance.
14. Keep guns unloaded until you are on the firing line and ready to use it. All firearms must have actions open (slide locked back) when away from the firing line. Magazines may be loaded in advance, but must be out of the weapon until properly deployed on the designated stall, lane, or area.
15. No rapid fire, shooting on the move, or drawing from holster.
16. All incendiary, tracer, black powder, or armor piercing ammunition is prohibited.
17. Hollow point & wad-cutters are permitted on steel target lanes. They are not permitted on plastic targets or on the pistol targets.
18. Pistols may be fired on the rifle lanes.
19. No rifles, long guns or shotguns may be fired on pistol lanes or on pistol targets. A pistol caliber long gun (a short barrel rifle chambered in 9mm), is allowed, if the barrel is 8 inches or less.
20. On rifle lanes, calibers up to .30-06 are permitted.
21. No uncased firearms allowed outside of shooting stall.
22. Any recreational or other non-emergency discharge of a firearm outside of the designated range area and safely down range from a designated stall/lane is strictly prohibited.

I ACKNOWLEDGE AND UNDERSTAND THAT if the Range Safety Officer or Line Instructor believes that I am or will be unsafe or dangerous, the Range Safety Officer or Line Instructor will remove me from the range, facility, or premises with no refund.

_____ Initial

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT The Event has no duty to undertake first aid or rescue operations or procedures in the event any such property damage or physical or emotional injury occurs, and that any such operations or procedures may result in compounding or increasing the damages or injuries.

_____ Initial

I FURTHER ACKNOWLEDGE AND UNDERSTAND THAT The Event makes no warranty as to the design, manufacture, maintenance, condition or fitness for any particular purpose of any RANGE facilities or equipment, including, but not limited: firearms, ammunition, targets, berms, lane barriers, eye/hearing protection, and first-aid supplies.

_____ Initial

As lawful consideration for being permitted by The Event to enter on the RANGE, to use RANGE facilities or equipment and to engage in or observe shooting and other activities at the RANGE, I AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS EXISTING ON THE RANGE AND IN ENTERING ON TO THE RANGE AND IN USING RANGE FACILITES OR EQUIPMENT AND IN ENGAGING IN OR OBSERVING SHOOTING AND OTHER ACTIVITIES AT THE RANGE.

_____ Initial

I, for myself and on behalf of my next of kin, heirs, guardians, representatives, successors, administrators, and assigns (collectively, "Releasing Parties"), hereby unconditionally and irrevocably agree to indemnify, defend, and hold harmless The Event, its organizers, officers, directors, agents, sponsors, volunteers, employees, contractors, affiliated entities, and the owners and operators of the range (collectively, "Released Parties") from and against any and all claims, demands, liabilities, damages, losses, causes of action, suits, judgments, costs, and expenses (including reasonable attorneys' fees and court costs) of any kind or nature whatsoever, whether known or unknown, foreseen or unforeseen, at law or in equity, arising out of or in any way relating to:

- my entry onto the range premises;
- my use of any range facilities or equipment;
- my participation in, or observation of, any shooting or event-related activities; or
- the actions or omissions of any guests or invitees.

This indemnity expressly includes, but is not limited to, claims for personal injury, death, or property damage suffered by me, my guests, or any third party, regardless of whether such claims arise in whole or in part from the negligence, acts, omissions, or failure to act (including negligent first aid or rescue efforts) of any of the Released Parties.

I further agree that this waiver, release, and indemnity is intended to be as broad and inclusive as permitted by applicable law and shall survive the conclusion of The Event.

_____ Initial

Further, I COVENANT NOT TO SUE The Event, its organizers, officers, directors, agents, sponsors, volunteers, employees, contractors, affiliated entities, and the owners and operators of the range (collectively, "Released Parties") from any and all injuries or damages of whatsoever kind and nature that I may sustain as a result of my use of the range, facility, or premises, or of direct or indirect use of the range, facility, or premises.

_____ Initial

I ACKNOWLEDGE AND AGREE that this Agreement shall be interpreted and enforced under the laws of the State of Tennessee, County of Williamson, and that the venue for any action or proceeding shall be the State of Tennessee, County of Williamson, without regard for the conflict of law rules of the State of Tennessee.

_____ Initial

I ACKNOWLEDGE AND AGREE that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision or portion is held to be invalid, void or otherwise unenforceable, I agree and intend that the remaining provision or portions shall continue and remain in full legal force and effect.

_____ Initial

I have carefully read this "Acknowledgement of Risk. Release & Indemnity Agreement". No other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement, which I sign voluntarily and of my own free will. I further acknowledge and agree that this Agreement may not be amended or modified. I UNDERSTAND THAT BY MY SIGNATURE I AM GIVING UP SUBSTANTIAL RIGHTS, THAT I AM AGREEING NOT TO SUE The Event AND RELEASING AND HOLDING HARMLESS "Band of Brothers" and/or "Band of Brothers Bootcamp".
